Teaching Philosophy

Students learn best when they understand why the information they are learning is important. In my classes, we take the time to tie information back to real life scenarios to help make those connections. I also create opportunities for participation with members from the business community. In addition, students need to understand that the learning process is a physiological one – we need to get their brain to change. Although my classes are in the business field, we talk about the brain a lot – how to treat the brain kindly (food, water, sleep, and exercise) and how to effect change in the brain (repetition, repetition, and repetition). Learning accounting isn't about being smart or not smart – it's about practicing enough to get your brain pathways to change. In my experience, incorporating these components into my courses increase student motivation, which in turn increases student learning and success.
